### Acceptable Forms of Residency

A valid military identification card and proof of residency are required at time of purchase. Acceptable forms of residency are; Florida driver's license, a Florida state issued ID card (must have a Florida address). Or a Florida based military ID. If you do not have one of the Florida IDs indicated above, then you must provide one of the following dated within the last 2 months evidencing a Florida residential address, a monthly mortgage statement; a Florida Vehicle Registration or Title; homeowner's insurance policy or bill, an automobile Insurance policy or bill; a utility bill; mail from a financial institution, including checking, savings, or investment account statement; or mail from a Federal, State, County or City government agency.
